## PRIVACY POLICY

INFORMATION ON THE PROCESSING OF PERSONAL DATA PURSUANT TO ARTICLE 13 OF REGULATION (EU) 2016/679

Pursuant to and for the purposes of Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, also referred to as the General Data Protection Regulation (hereinafter "GDPR"), hereinafter also the "Regulation", we inform you that the personal data you voluntarily make available to SicilyHub (hereinafter also the "Company") will be processed in compliance with the applicable legislation on the protection of personal data.

#### 1. DATA CONTROLLER AND DATA PROTECTION OFFICER

The Data Controller is SicilyHub S.B.P.A. (hereinafter only "SicilyHub"), in the person of its legal representative pro tempore, with registered office in Rome, via Nizza, 110 and operational headquarters in Misterbianco (Catania), at Via Franchetti, snc. The Data Protection Officer can be contacted at the email address info@siciliafiera.it for any needs relating to the processing of personal data.

#### 2. PURPOSE AND LEGAL BASIS OF THE PROCESSING

Your personal data will be processed for the following purposes:

- A. the establishment and performance of the contractual relationship between you and SicilyHub, including but not limited to the activities related to the performance of the contract: sale of tickets, rental of the exhibition area, organisation of events including online in which you are interested in participating, provision of services ancillary to your participation, planning of services requested by you, publication of exhibitor details in the event catalogue, etc. With reference to this purpose, the legal basis of the processing is the performance of contractual or pre-contractual obligations in relation to a contract to which you are a party. Any refusal on your part to provide the data would make it impossible for SicilyHub to provide the requested service. It should be noted that any processing of special categories of personal data will be carried out exclusively in the event that such data is communicated or made public directly by you. Such processing will be legitimate on the basis of Article 9, paragraph 2, letter e) of the Regulation. The provision of such data is never mandatory;
- B. the fulfilment of all regulatory, tax and administrative requirements imposed on SicilyHub by law and by contracts. With reference to this purpose, the legal basis of the processing is the fulfilment of legal obligations imposed on SicilyHub. Any refusal on your part to provide the data would make it impossible for SicilyHub to provide the requested service;
- C. the development of statistical and market studies and research. With reference to this purpose, the legal basis of the processing is your specific consent, in the absence of which SicilyHub will not be able to carry out market research concerning your data. In any case, you may still use the services offered by SicilyHub;
- D. the performance of profiling activities aimed at understanding your possible needs in relation to the offer of new services based on the preferences you express. With reference to this purpose, the legal basis of the processing is your specific consent, in the absence of which SicilyHub will not be able to carry out profiling activities using your data. In any case, you may still use the services offered by SicilyHub;
- E. the performance of commercial and marketing activities connected to the activities of SicilyHub by post, internet, telephone, email, MMS and SMS, from Italy or abroad. With reference to this purpose, the legal basis of the processing is your specific consent, in the absence of which SicilyHub will not be able to carry out the aforementioned commercial activities. In any case, you may still use the services offered by SicilyHub;

  F. the sending of your data to companies of the Group to which SicilyHub belongs and to third parties such as exhibition organisers or partners involved in the organisation of individual fairs, including those based in non-European countries, in order to enable the latter to launch their own marketing initiatives related to their products and services. With reference to this purpose, the legal basis of the processing is your specific consent, in the absence of which SicilyHub will not be able to send your data to third parties. In any case, you may still use the services offered by SicilyHub;
- G. to allow SicilyHub to take videos and/or photographs during shows and events for publication on our websites/landing pages and social media profiles (e.g. X (formerly known as Twitter), Facebook, YouTube, etc.) and in brochures, catalogues, flyers and other hard-copy event promotion materials. The legal basis for the processing is the legitimate interest of the Data Controller, as the filming and photography carried out by SicilyHub in the context of this purpose is exclusively generic. Any refusal on your part would make it impossible for SicilyHub to provide the requested service. Any specific photographs or footage will, however, be taken by SicilyHub only with your consent, which will be requested where necessary, accompanied by a suitable policy and a dedicated consent form.

#### 3. DATA PROCESSING METHODS

Your personal data will be processed using the appropriate hard copy, electronic and/or computerised tools, on the basis of procedures strictly correlated with the above purposes and in any event in such a manner as to ensure the security and confidentiality of the data. It is specified that SicilyHub does not process your data for the purpose of making decisions based on automated processing that produce legal affects or that significantly affect the person, pursuant to Article 22 of the Regulation.

#### 4. RECIPIENTS, CATEGORIES OF RECIPIENTS OF PERSONAL DATA AND TRANSFER OF DATA TO THIRD COUNTRIES

The shareholders, members of the board of directors or other administrative bodies and, in any case, the Data Protection Officer, the External Processors, the Data Processors and/or individuals authorised to process the data as designated by SicilyHub may become aware of your personal data in carrying out their duties. Your personal data may be disclosed to any parties that provide SicilyHub with services that are instrumental to the purposes indicated above. These include, by way of example, parent companies, subsidiaries, investee and/or associated companies, joint venture partners; individuals, entities and/or companies that manage and/or participate in the management and/or maintenance of the websites and electronic and/or computerised tools used by us, photographers and/or video-makers who make the video/audio materials or carry out the related post-production, journalists and journalistic publications, companies entrusted with services necessary for the organisation and management of events, including but not limited to: installation of staging and equipment, publishers of paper and online catalogues, logistics, security, surveillance, first aid, event hosting staff, etc.), diplomatic representatives, consultants, legal firms, banks, providers of marketing and communication services; other parties in charge of the process of selecting and managing the related benefits for buyers (such as insurance companies, travel agencies, hotels), etc.

The up-to-date list of Data Processors is available at the headquarters of the Data Controller and can be requested by sending a message to the email address info@siciliafiera. it. Your personal data may be communicated and/or transferred abroad, in accordance with the provisions of the applicable legislation (Articles 45 et seq. of the Regulation), including to countries outside the European Union or, where appropriate, to the countries where the recipients referred to in the preceding section are based. In all such cases, the transfer is necessary for the execution of the contract with the data subject or for the execution of contractual measures adopted at your request, or to establish, exercise or defend a right in court; in general, it is carried out on the basis of an adequacy decision of the Commission (Article 45 of the GDPR) or in accordance with the standard data protection clauses or other appropriate safeguards pursuant to Articles 46 or 49 of the GDPR. In the event that a Commission adequacy decision has not been adopted and the other safeguards established by the GDPR are not applicable, the communication and/or transfer of data outside the European Union will be subject to your consent once you have been informed that the country in question does not provide an adequate level of protection.

#### 5. DATA STORAGE

#### 6. RIGHTS OF THE DATA SUBJECT

# GENERAL REGULATIONS OF MANIFESTATION

## **Article. 1** ORGANIZATION

The general organization of the event will be handled by "Sicily HUB SBPA", with operational headquarters in Corso Carlo Marx n. 19 – Misterbianco (CT) – PI 14045481000, hereinafter for brevity called "ORGANIZING BODY".

## **Article. 2** ADMITTED GOODS

Those activities that the OB at its sole discretion deems appropriate to accept are admitted to the event. Products, machinery, appliances, equipment and services that do not comply with the permitted typologies will be excluded at the expense and risk of the exhibitor.

# **Article. 3** APPLICATION FOR PARTICIPATION

The application for participation must be completed, accompanied by a valid certificate of registration at the Chamber of Commerce to which you belong, on the appropriate form and delivered to the OB Secretariat (art. 1) by certified email. Applications received by the deadline set for closing registration, correctly completed and signed, will be examined.

The OB decides unquestionably whether or not to accept the application based on the following criteria:

- Spaces available
- Qualification of applicants
- Type of products/services displayed

By signing the relevant participation application, the exhibitor irrevocably undertakes to participate in the event by accepting all the provisions of the "GENERAL PARTICIPATION REGULATIONS" contained in these regulations, as well as any other rule, modification, integration or derogation, appropriate to better regulate the event and related services.

These rules and provisions have equivalent value to this general regulation and therefore have the same mandatory character.

The written and non-written publications and communications of the OB, containing rules and provisions before, during and after the event, are intended to all intents and purposes as an integral part of these general regulations.

## **Article. 4 STAND ALLOCATION**

The allocation of available places is carried out by the OB, taking into consideration any indication of position by the exhibitor, however the OB reserves the right to make non-questionable variations and/or modifications which may be necessary for technical reasons. and/or organizational needs. Any different stand assignment will be communicated to the exhibitor at least 10 days later. before the start of the event. The stands will be made available to exhibitors one day before the event and must be set up before the start of the event itself.

## Article. 5 PARTICIPATION FEE AND PAYMENT

The exhibitor is required to pay the participation fee for the event to the OB, in the manner and within the terms established in the previous subscription contract. At the same time as signing the participation application and the general regulations, the exhibiting company must pay a deposit, as established by the OB and indicated in the respective subscription contract, while the balance must be paid no later than the date indicated in the documentation. Stands not confirmed in time will be assigned to applicants on the waiting list who have previously submitted an application for admission to the event. In any case, payments other than those indicated in the subscription contract are not granted. Every "external" company that wishes to promote itself within an exhibition space through equipment, machinery, services or promotional advertising material (banners, videos, brochures, etc.) is required to pay a registration fee as a "guest" company of €500.00 + VAT. A right of preemption on the exhibition spaces used in the previous edition is recognized, which can only be exercised on condition that the Exhibitor is up to date with all payments to the Organizing Body.

The exhibitor who for any reason renounces participation in the event must immediately notify the OB via PEC and/or registered letter with return receipt.

In case of cancellation communicated within 15 days from the start of the event, the OB will retain 30% of the entire participation fee as a penalty, whereas, however, if the communication of the cancellation is received later, the OB will retain the entire amount paid, except in the case in which the OB himself manages to occupy the stand with another exhibitor on the waiting list and without prejudice to the 30% withholding as a penalty.

## Article. 7 STAND SETUP

The stand installations must be contained within the surface area of the assigned area. The exhibitor is required to exhibit only the products/services listed in the registration forms. All responsibility, therefore, regarding the construction of the stands and any damage that may be suffered to persons or property belonging to the OB or third parties, lies exclusively with the exhibitor.

# Article. 8 RETURN OF THE EXHIBITION AREAS

The day following the end of the event, and not before, the exhibition area must be cleared and returned to the OB, who will check the state of the places, to issue a release on the correct use of the same by the Exhibitor. If this does not happen, the OB reserves the right to proceed with the removal and storage of the material. In this case, the non-compliant exhibitor will have to reimburse the OB for the out-of-pocket expenses incurred for transport, storage of the material and cleaning of the stand.

## Article. 9 ACCESS TO THE EVENT AREA

The event area is open on the days and hours that the OB will establish and disclose publicly. ## **Article. 10 GENERAL SURVEILLANCE**

During the period and hours in which visitor access is permitted, the exhibitor is required to monitor his stand directly or with trusted persons.

## **Article. 11** LIABILITY FOR DAMAGES

The exhibitor will be liable towards the OB for any actions and/or fault of its own, that of its employees, assistants, collaborators, suppliers, for all damages caused to the OB or to third parties in general. Furthermore, the exhibitor is responsible for all damage caused to the buildings and equipment made available to him. The stands must be returned in the conditions in which they were delivered and the costs of restoration for damage caused are borne by the exhibitors.

## **Article. 12** DISCLAIMER OF LIABILITY

The exhibitor exonerates the OB from any liability deriving from theft and/or direct and indirect damages that could arise from acts or omissions of other exhibitors or third parties in general during the events, including the set-up and dismantling period. Furthermore, the OB is not liable for any damage caused by representatives of the companies and/or by technical personnel appointed for this purpose, during the movement, ordered by the same, of works and objects owned by the exhibitor, where exceptionally this becomes necessary and with the accepted participation application means express formalization of indemnity as an exemption from liability of the OB, also for workplace safety profiles.

## **Article. 13** TECHNICAL SUPPLIES - SERVICES

## **Article. 15** PAID ADVERTISING FORMS

Inside and outside the exhibition area, any form of propaganda or advertising must be carried out exclusively through the OB, which reserves the management, including through its concessionaires.

#### **Article. 16 PROHIBITIONS**

In particular, exhibitors are prohibited from:

- Display prices on the items displayed.
- Transfer the assigned exhibition areas to third parties, even partially, or exchange them.
- Display products that conflict with the product categories authorized by the BO.
- Display signs or samples, even simply indicative, on behalf of unrepresented companies.
- Carry out propaganda operations outside your stand such as leafleting in the corridor or in other areas of the exhibition area, without prior authorisation.
- Leave cars or vehicles inside the exhibition area outside the spaces and at permitted times.

In case of non-compliance, even with just one, of the prohibitions indicated above, the participation contract may be terminated, without the need for a ruling from the Judge, but with simple written communication to the exhibitor at his stand.

This will result in the immediate closure of the stand, without prejudice to the fees all due by the exhibitor, in addition to any damages.

# Article. 17 POSTPONEMENT, REDUCTION, SUSPENSION OF THE EVENT
